Katy Perry has scored a major victory in her long, messy legal war over the Montecito, California, mansion she bought more than five years ago. Carl Westcott, an 85-year-old disabled veteran and the former owner of the property, has been ordered to cough up \$1.84 million after a judge ruled the pop star lost out on hefty rental income during the drawn-out fight, per People. Kameron Westcott/Facebook The dispute centered on the \$15 million estate Perry, 41, and her ex, Orlando Bloom, 48, snapped up in one of California's most elite neighborhoods back in July 2020. Just days after signing the contract, Westcott tried to pull the plug. He claimed he had been recovering from major back surgery and was under heavy medication that left him too impaired to understand what he was signing. He also pointed to Huntington's Disease, the pre-existing neurological condition he was diagnosed with in 2015, as further proof that he lacked the capacity to approve the multimillion-dollar sale. Village Properties Perry and Bloom's team, however, fired back and insisted the deal was valid and that Westcott had seller's remorse after realizing he could have received more money for the property in a fast-climbing market. A judge eventually sided with Perry, ruling that Westcott was "coherent, engaged, lucid and rational" at the time he authorized the sale. With that decision, the court shut down his attempt to rescind the deal - although the case still didn't end there. Perry and her ex, Orlando Bloom, originally purchased the \$15 million mansion from Westcott in July 2020. katyperry/Instagram Westcott was diagnosed with Huntington's Disease in 2015. Kameron Westcott/Facebook Once the sale was officially upheld and Perry finally secured title to the mansion in May 2024, she turned around and sued for damages on Nov. 21, 2025. The "Firework" singer argued that the years-long delay prevented her from renting out the property, which she said could have brought in millions. She also claimed that the home fell into disrepair during the dispute, which created a long list of costly fixes. Perry initially sought nearly \$5 million from Westcott, combining what she said was more than \$3.5 million in lost rental income and more than \$1.3 million in needed repairs. Kameron Westcott/Facebook After reviewing months of financial documents, property assessments and expert testimony, the judge agreed she was owed money - although not the full amount she initially demanded. In the final ruling, the judge awarded Perry roughly \$1.84 million, which was made up of a calculated rental-value loss minus offsets for retained capital and interest, plus an approved repair-cost amount, per People. The mansion at the center of the controversy, meanwhile, sits on a 2.5-acre property and includes eight bedrooms, 11 bathrooms, multiple guest spaces, ocean views, manicured grounds, an infinity pool, a jacuzzi and plenty of privacy. GC Images Though Perry and Bloom gained legal control of the compound months ago, it remains unclear whether they ever moved in before splitting up in June 2025. A final judgment hearing connected to the financial settlement is reportedly scheduled for Dec. 30. The Post has reached out to Perry and Bloom's reps for comment. A judge signed a proposed order Tuesday that will award Perry the \$1.8 million so long as neither party files a viable objection in the next ten days. The money represents the damages Perry suffered when Westcott bailed on their \$15 million purchase agreement in 2020, claiming he lacked capacity when he signed it. Westcott sued Perry through her business manager, trying to overturn the sale, but he lost at a bench trial during the first phase of the legal battle. Perry had asked for an award of \$4.7 million in damages during phase two of the trial. Westcott argued her damages should be limited to only \$260,000. In his proposed ruling, Los Angeles County Superior Court Judge Joseph Lipner found a middle ground. He said Perry deserved \$2.8 million for lost rental value while the property was in limbo, and \$260,000 for repairs for things like a fallen tree and water damage. But he then deducted \$1 million because Perry was able to invest her money elsewhere during the fight, and because Westcott lost interest on that amount. Rolling Stone's attempts to reach lawyers on both sides were not immediately successful on Wednesday. The battle over the luxury property started soon after Westcott signed the sales contract with Perry in July 2020 Within weeks, the businessman sought to undo the deal. He, his family, and his lawyers would go on to claim he was suffering from a degenerative brain disease, symptoms of dementia, post-operative delirium, and the effects of heavy painkillers following a lengthy back surgery when he finalized the contract. At the liability trial in 2023, Perry and her lawyers brought in text messages, emails, and witness testimony showing Westcott was alert and cognizant during his sale of the Montecito estate. They showed Westcott was so engaged, he even courted a rival bid from yet another high-profile interested buyer, Maria Shriver, before going with Perry initially faced public backlash over allegations she tried to push an elderly, ailing veteran out of his home against his wishes, the trial revealed that Westcott purchased the coastal estate on May 29, 2020, just six weeks before signing his deal with Perry's representative, Bernie Gudvi. Lawyers for Gudvi argued that Westcott badgered his broker about when Perry's initial offer was expected to land, rejected her initial \$13.5 million bid, signed a counteroffer for \$15 million on July 15, 2020, actively organized Perry's tour of his property on July 17, 2020, agreed to extend the deadline on his counteroffer when the initial deadline lapsed, and criticized his agent for requesting a five percent commission. In his 2023 ruling siding with Perry and ratifying the deal, the judge noted that Westcott's own medical expert failed to "offer a cogent explanation" that would allow the court to find Westcott "lacked competence" to sign the sales contract. After Perry prevailed, she placed \$9 million in escrow and took control of the property in April 2024, leaving the remaining \$6 million of the purchase price unpaid pending the outcome of the damages phase. She alleged the four years she had to wait to take control of the property caused her to lose more than \$3 million in fair-market rental income, and that Westcott's "lack of maintenance" while the litigation was pending caused \$2.29 million in necessary repairs to get the property back up to the condition it was in 2020. (The estate includes a main house, a three-bedroom guest house, a gym building, a pool, and an equipment building.) In court filings, Perry and her reps alleged the house suffered "pervasive flood damage" in early 2024 and had a large tree fall on a structure, cracking its foundation. Westcott claimed Perry only produced estimates for the repair work, not final contracts or receipts. At the hearing earlier this year, Westcott's lawyer, Andrew J. Thomas, said that after Perry took control of the house had to have been in good shape for Perry to attract such high-profile tenants. Perry's lawyer said the singer wasn't seeking "reimbursement" for her completed work because she wasn't obligated to restore the house and ultimately made some changes. He claimed the onus was on Westcott to hand over the house in its purchase agreement condition, and for that reason, the estimates Perry submitted reflected what it would have cost to get the property back to the original condition. Perry has been in the news repeatedly this year. She took an 11-minute trip to sub-orbital space aboard one of billionaire Jeff Bezos' Blue Origin rockets in April, shortly before news of her split from longtime partner Orlando Bloom surfaced in June. She was later spotted dining out with Justin Trudeau, the former prime minister of Canada. He later popped up at one of her concerts, fueling ongoing speculation that the two are dating. It has been seven years since Witness: The Tour, and the multi-hyphenate now has a 4-year-old daughter, Daisy Dove Bloom. She has retired from her judging post on "American Idol." And she has added a critically acclaimed Las Vegas residency to her resume. But one thing remains the same about the chart-topping pop star as she heads into her global Lifetimes Tour, for which she announced the U.S. dates on Monday: Her famously over-the-top concerts will still be like "Disneyland on wheels." Among the details she was willing to share in a sit-down with USA TODAY about her upcoming tour is this: It's going to be a "dance party." Perhaps a more surprising nugget for fans is that Perry is looking for "feedback" to influence her set list, which will "change and alternate" and sometimes include some "deep cuts" from her discography. "When I made the record (last year's '143'), it was a celebration of becoming a mother and all the love and the cliches that are true with it. All that unconditional love I never felt," Perry tells USA TODAY. "It is a freeing, dance-heavy ... celebratory record. And that is exactly what the tour will be." Shop Katy Perry Lifetimes Tour tickets After kicking off April 23 in Mexico City, Perry tells USA TODAY. will return stateside in May, cross the globe to perform in Australia, come home to her West Coast "California Gurls" in July before singing across Canada, then do a stint of shows in the U.S. before going to South America and Europe. In total, she has 40 shows and counting in the North American leg of the 2025 Lifetimes Tour, with 75 total concerts across the globe. And though it's in support of her most recent album, Perry knows exactly what fans around the world want to see her perform: the chart-topping hits that have made her one of the bestselling musicians of all time. "Lifetimes is going to incorporate the journey that I've been on for over 17 years and celebrate it," she says. "I'll be singing a hybrid of songs; I feel a total responsibility to my audience to give them that sing-along feeling. But I will be introducing them to a few new ones, which I'm really excited about." Perry promises fans performances of "California Gurls," "Dark Horse," "Firework" and "Roar. "These bops will make for what she promises will be "a real fun dance party," but the mom also wants fans to keep safety in mind: "Please wear sensible shoes and stay hydrated." From "143," Perry plans to perform her collaboration with Doechii, "I'm His, He's Mine," "All the Love" and, of course, the tour namesake dance club single "Lifetimes." But Perry is allowing some flexibility with the set list: "I am open to submissions. I might be doing a poll on social media," she teases. Perry revealed there's a "special section that we've carved out of the show, Perry concedes, "I'll have to be prepared, and I use a prompter." With so many songs in her discography, it seems nothing will be off-limits. "There will be some deep cuts that have never been played. So if you're a true fan and you want to hear those deep cuts, those B sides, there's going to be that moment, and it's all in their hands," she says. "Yeah, some songs that have never seen the light of day live, we'll finally have the opportunity (to play), which I'm really excited about because the real fans are going to be like, 'Oh my God, this is it.'"Shop Katy Perry Lifetimes tour ticketsThis year, Perry will add a new member to her touring crew: Daisy, her daughter with partner Orlando Bloom. Fans last saw Daisy make a brief cameo in 2023 during the last show of Perry's "Play" residency in Las Vegas. "She is so curious, and she's such an extrovert. And she loves seeing Mommy happy. She loves seeing the shows," Perry says. "I'm excited that I get to bring her around the world on my first world tour with her." She compares sharing music with her 4-year-old to the feeling of celebrating Christmas with a child: "Everything's just brighter again. Everything tastes better, everything looks better, everything's more fun because you see it through the eyes of a child." With Daisy, whom she credited for influencing the visual spectacle that was her Vegas residency, Perry says "a lot more play gets injected into (the show), and it's not that serious." While traveling the globe, Perry will not only be responsible for entertaining arenas full of fans but also her preschool-age daughter. "I want submissions for where I should take her on days off," she says, listing parks, children's museums and water parks as places she's seeking in each city. "I'm going to show her the world."
